What is this product?

Type:

This product is classified as a UCITS.

The unit class is actively managed and invests in bonds issued by Emerging Market countries and their state-owned and state-guaranteed companies. The bonds the unit class invests in are normally issued in USD, but at least 80% of the currency risk is hedged to euro or Danish Kroner. The unit class is covered by Article 8 of the Disclosure Regulation and thus promotes environmental and/or social characteristics as well as good management practices. The investment strategy integrates ESG through a screening and analysis process for the issuers, the screening and analysis process is described in the Securities Fund's prospectus. The share class's return is primarily determined by interest rate trends in Emerging Markets. You are normally paid a dividend each year after the end of the financial year. The remaining part of the share class's return arises as changes in the price of the share class's certificates.

Maturity:

The unit class has no date of termination. However the unit class may be discontinued if the general meeting so decides (for instance by way of winding-up or merger) and if the conditions attached to it are complied with.

Under normal circumstances you can always sell your units at the current price on days when banks are open. In connection with a sale exit charges are paid, see "What are the costs?".

Objective:

The objective is to obtain a return that equals or outperforms the return of the benchmark of the unit class, which is JP Morgan Next Generation Emerging Markets hedged to Danish kroner. The portfolio of the unit class is designed without reference to the index and will not copy it.

In its efforts to achieve the objective, the fund's investments may deviate from the benchmark and investments may be made in securities that are not included in the benchmark. This may result in the risk and return of the unit class deviating from the benchmark.

Intended retail investor:

Unit class units have not been admitted to trading on a stock exchange. Units are targeted at and reserved for institutional investors.

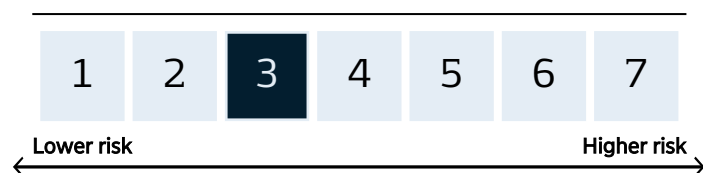
The unit class targets investors who accept and understand that the value of the unit class is directly related to developments in the value of the underlying investments and that this value will fluctuate over time. Investing in the unit class does not require investors to have specific knowledge of financial markets or instruments.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less.

The unit class invests in bonds, which involves a risk that a bond issuer is unable to meet its payment obligations. The return of the unit class will be affected by for instance changes in interest rates, exchange rates, economic developments as well as changes in the financial circumstances of the bond issuer, including the rating of the issuer.

Be aware of the currency risk. The currency of this unit class may differ from your country's currency. The payments you receive are in the currency of this unit class instead of your country's currency and the final return will depend on the exchange rate between the two currencies. This risk is not

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions will likely impact the return.

included in the indicator above. This product does not provide any protection against future market developments, so you may lose some or all of your investment.

Other important risks not included in the summary risk indicator:

The bonds invested in may at times be less liquid, which means that greater price fluctuations in these bonds must be expected, particularly in turbulent market conditions. This may mean that unit class units may not be saleable at times or that exit costs are increased (see "What are the costs?").

Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if Syd Fund Management A/S is unable to pay out?

The fund's assets are held in custody with its depository. Consequently holdings will not be affected by the insolvency of the management company. If the depository or a representative appointed by the depository becomes insolvent, the fund may however face a financial loss. This loss is not covered by any investor compensation or guarantee scheme. This risk is however mitigated to a certain extent since according to existing legislation the depository must segregate its own assets from the fund's assets. The depository is moreover liable with respect to the fund and its investors for any loss, including losses arising as a result of the depository's breach, fraud or deliberate non-performance of its obligations (subject to certain limitations).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

In the first year you would get back the amount invested (0% in annual return). In the other holding periods we have assumed that the product will perform as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years. Given the underlying investments as well as the objective to generate a stable long-term return subject to risk, a holding period of a minimum of 4 years is recommended. There is no maximum recommended holding period.
