Investment Overview

The Fund aims to preserve capital while seeking to maximize its investment return in US dollar over the short term. The Fund qualifies as a short-term variable net asset value money market fund under the European Money Market Fund Regulation. The Fund pursues an actively managed investment strategy and invests mainly in high-quality Money Market Instruments such as short-term debt securities of superior quality issued by governments, government-related entities and corporations, and commercial paper issued by first-rate companies, and certificate of deposit of prime banks.

Glossary

The OCF is calculated by taking the relevant main material costs paid out over the 12-month period indicated and dividing them by the average net assets over the same period.
