## Objectives and investment policy

This Product is actively managed. The benchmark Bloomberg Euro Aggregate Corporate RI is used for performance comparison only. The Product is not benchmark constrained. Nevertheless, due to similar geographical and thematic constraints, investors should be aware that the Product's risk and return profile may, from time to time, be comparable to the risk and return profile of the benchmark.

The Product seeks to increase the value of its assets over the medium term by investing in investment grade bonds and/or securities treated as equivalent denominated in any currencies and issued by European companies or companies operating in Europe.

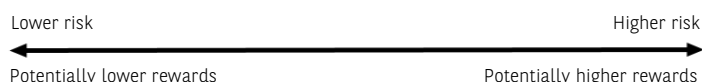
After hedging, the Product's exposure to currencies other than EUR will not exceed 5%.

Environmental, social and governance (ESG) criteria contribute to, but are not a determining factor in, the manager's decision making.

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

- Why is the Fund in this specific category?  
The risk category is justified by the investment mainly in Interest Rate instruments. The investor's attention is drawn to the fact that an increase in interest rates results in a decrease in the value of investments in bonds and debt instruments and more generally fixed income instruments.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- **Credit Risk:** This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- **Operational and Custody Risk:** Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.

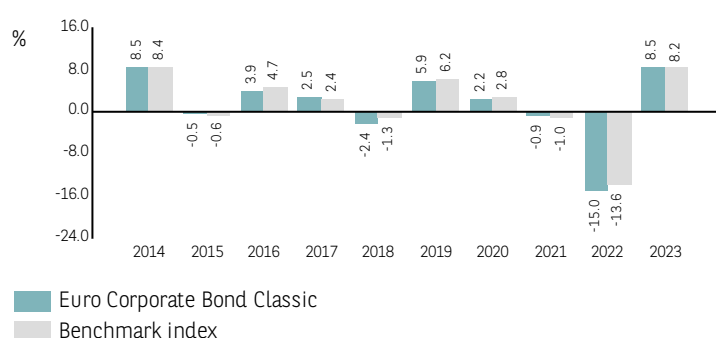
This figure may vary from year to year. It excludes:
