Objectives and Investment Policy

Templeton Asian Smaller Companies Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

 equity securities issued by smaller companies (i.e. with a market capitalisation within the range of the market capitalisations of companies included in the MSCI AC Asia ex-Japan Small Cap Index) located in, or doing significant business in, Asia (excluding Japan)

The Fund can invest to a lesser extent in:

- equity, equity-related (such as participatory notes) or debt securities issued by companies of any size located in any country, including any other emerging markets
- derivatives for hedging and efficient portfolio management

The investment team uses global research expertise with a focus on identifying companies in Asian countries, including emerging markets, that it believes to be overlooked by other investors and to offer an opportunity for increased value over the long term.

The benchmark of the Fund is the MSCI AC Asia ex-Japan Small Cap Index-NR. The Fund uses a benchmark index to define small caps as the range of

acceptable market caps at initial purchase and also as a reference for Investors to compare against the Funds' performance. The Fund is not obliged to hold any of the benchmark constituents and may indeed invest up to 100% of its net assets outside the benchmark.

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Terms to Understand

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Equity securities: Securities that represent an ownership stake in a company.

Why is the Fund in this specific category?

The Fund invests mainly in equity securities of smaller companies located in or doing significant business in Asia. Emerging markets have historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can

fluctuate significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:


