What is this product?

Type

The product is a share class of the sub-fund Franklin U.S. Low Duration Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to earn high income while preserving investors' capital over the medium term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- higher-quality debt securities issued by the U.S. government and its agencies (up to 100% of the Fund's assets), and by corporations located in the U.S., including mortgage- and asset-backed securities

The Fund can invest to a lesser extent in:

- debt securities of issuers located in other countries (limited to 25% of assets)
- non-U.S. dollar investments (limited to 20% of assets)
- lower-quality debt securities (limited to 20% of assets)
- Mainland China through the Bond Connect or directly (limited to 5% of assets)

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

The investment team focuses on securities and industry sectors that it believes will provide the best opportunities over the long term.

The Fund aims to maintain an average duration of less than three years.

The benchmark of the Fund is the Hybrid: Bloomberg US Treasury (1-3 Y) Index to 30 Sep 2014 then Bloomberg US Government & Credit (1-3 Y) Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

Intended retail investor

The Fund may appeal to investors looking to maximise income while seeking capital preservation by obtaining exposure to debt securities issued by government and corporations located in the U.S. as well as derivatives and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who have an some knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

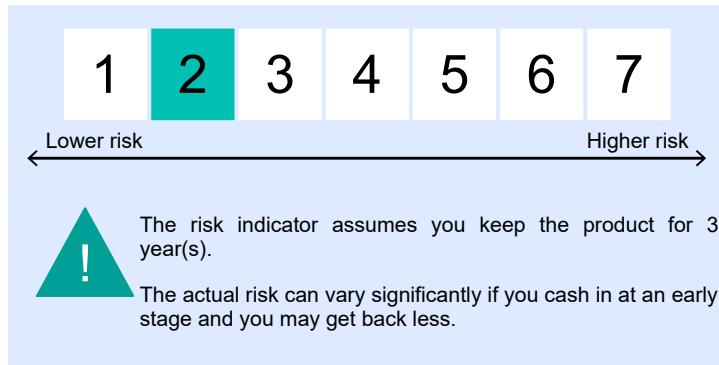

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10,000 is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.2% before costs and -2.7% after costs.

Recommended holding period: 3 year(s)

This Fund has no minimum required holding period. We consider that the 3 year recommended holding period is appropriate because the Fund is designed for medium-term investment. The value of your investments may go down as well as up irrespective of the period you are holding your investments, depending on such factors as the performance of the Fund, movements in stock and bond prices, and conditions in financial markets generally.
