What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Agriculture is a fully collateralised, UCITS eligible Exchange-Traded Product (ETP) designed to provide investors with a total return exposure to a basket of Agriculture futures contracts. The ETP aims to replicate the Bloomberg Agriculture Sub Total Return Index (BCOMAGTR) by tracking the Bloomberg Agriculture Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Agriculture Sub Total Return Index rises by 1% over a day, then the ETP will rise by 1%, excluding fees. However if the Bloomberg Agriculture Sub Total Return Index falls by 1% over a day, then the ETP will fall by 1%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
