What is this product?

Type

English law governed, certificated, registered, collateralised debt security.

Objectives

WisdomTree Industrial Metals Enhanced is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Industrial Metals futures contracts. The ETC provides a total return comprised of the daily performance of the Optimised Roll Industrial Metals Total Return Index (EBCIINTR), adjusted to reflect fees and costs associated with the product. For example, if the Optimised Roll Industrial Metals Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Optimised Roll Industrial Metals Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

The moderate scenario for where you exit after the recommended holding period occurred to the Optimised Roll Industrial Metals Total Return Index between 19/02/2015 and 12/01/2018. The favourable scenario for where you exit after the recommended holding period occurred to the Optimised Roll Industrial Metals Total Return Index between 12/04/2019 and 07/03/2022.
