## What is this product?

#### Type

The product is a share class of the Sub-fund Franklin S&P 500 Paris Aligned Climate UCITS ETF (the "Fund") which is part of the Franklin Templeton ICAV (the "Umbrella Fund"), an Irish collective assetmanagement vehicle constituted as an umbrella fund with segregated liability between Sub-Funds with registration number C167746 and authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### Objectives

#### **Investment Objective**

Franklin S&P 500 Paris Aligned Climate UCITS ETF (the "Fund") provides exposure to large capitalisation US stocks which are aligned to the transition to a low carbon economy.

#### **Investment Policy**

The Fund is classified as Article 8 under the EU Sustainable Finance Disclosure Regulation. The Fund is passively managed and seeks to track the performance of the S&P 500 Net Zero 2050 Paris-Aligned ESG Index (the "Index") as closely as possible, regardless of whether the Index level rises or falls. The Index provides exposure to US large capitalisation securities selected from the S&P 500 Index (Net Return) (the "Parent Index") which are better aligned with the move towards a low-carbon economy and helps investors align their investments to the Paris Climate Agreement

The Index is constructed to follow the EU Paris-aligned Benchmark (EU PAB) Regulations (Regulation (EU) 2019/2089) (the "PAB Regulations"). The Parent Index includes 500 of the largest companies by market capitalisations in the US. The Index has been constructed to align with the transition to a low carbon economy. Relative to the Parent Index, the Index (i) overweights those companies which are committed to reducing greenhouse gas emissions, and (ii) will have a 50% decarbonisation. In addition, the Green House Gas Intensity of the Index must reduce by 7% annually. These criteria are applied to 100% of the Parent Index and result in the Index having a weighted average ESG score which is greater than or equal to the weighted average ESG score of the Parent Index after 20% of the worst ESG scoring companies are removed from the Index and their weights redistributed proportionately to the remaining components.

Relative to the Parent Index, the Index aims to overweight companies which are exposed to climate transition opportunities and underweight those companies which are exposed to climate transition risks. The Index seeks to reduce the weight of companies assessed as high carbon emitters and increase the weight of companies with credible carbon reduction targets while achieving both a modest tracking error and a low turnover relative to the Parent Index. The criteria set out above are applied to at least 90% of the constituents of the Parent Index and result in a Green House Gas Intensity reduction of at least 20% for the Index relative to the Parent Index.

The securities in which the Fund invests will be primarily listed or traded on recognised markets globally in accordance with the limits set out in the UCITS Regulations.

The Fund may use derivatives for efficient portfolio management purposes only.

The Fund's shares are listed and traded on one or more stock exchanges. Investors can deal in shares daily through a broker on stock exchange(s) on which the shares are traded. Income from the Fund's investments will be reinvested and not distributed to investors.

#### **Share Class Policy**

For accumulation shares, income from investments is reinvested in the Fund and reflected in the price of shares.

### Processing of subscription and redemption orders

The Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, only authorised participants (e.g. select financial institutions) may deal in shares directly with the Fund. Other investors can deal in shares daily through a broker on stock exchange(s) on which the shares are traded.

#### Intended retail Investor

The Fund may appeal to investors looking to track the performance of US large capitalisation stocks and who willing to hold their investment over the medium to long term, for a minimum period of 3 to 5 years. The Fund may be suitable for investors who do not have specific knowledge and/or experience of financial markets and who understand that they may not get back the full amount invested in the Fund.



## What are the risks and what could I get in return?

#### **Risk Indicator**





The risk indicator assumes you keep the product for 5 year(s).

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. State Street Custodial Services (Ireland) Limited, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

#### What are the costs?

#### Costs over Time
