### **Objectives**

WisdomTree Wheat - EUR Daily Hedged is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Wheat futures contracts currency hedged in EUR. The ETC aims to replicate the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index (BUWHDET) by tracking the Bloomberg Wheat Sub Euro Hedged Daily Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index for the Bloomberg Wheat Sub Euro Hedged Daily Total Return Index and providing the ETC will fall by 1%, excluding fees.
