### What is this product?

#### Type

Jersey law governed, uncertificated, registered, collateralised debt security.

#### Objectives

WisdomTree Wheat 2x Daily Leveraged is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged exposure to Wheat . The ETC provides a total return comprised of 2 times the daily performance of the Bloomberg Wheat Sub Excess Return Index (BCOMWH), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Wheat Sub Excess Return Index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. However if the Bloomberg Wheat Sub Excess Return Index falls by 1% over a day, then the ETC will fall by 2%, excluding fees. You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of 2 (the "Leverage Factor"). This is because the Leverage Factor is reset on a daily basis (i.e. the Leverage Factor is applied to the performance of the Index on each day). The daily reset has a "compounding effect" which means that, the more volatile the performance of the Index, the more the performance of the product will deviate from the performance of the Index (multiplied by the Leverage factor) over a given period of time.

#### Term

### What are the risks and what could I get in return?

The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Wheat 2x Daily Leveraged between 27/12/2019 and 30/12/2019. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Wheat 2x Daily Leveraged between 07/03/2022 and 08/03/2022. Where period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
