#### **Objectives**

WisdomTree Wheat is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Wheat futures contracts. The ETC aims to replicate the Bloomberg Wheat Sub Total Return Index (BCOMWHTR) by tracking the Bloomberg Wheat Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Wheat Sub Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. ## What are the risks and what could I get in return?
