## What is this product?

Type: Shares of a Sub-Fund of MULTI UNITS LUXEMBOURG, a SICAV.

**Term:** The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed.

The investment objective of the Fund is to track both the upward and the downward evolution of the MSCI Emerging Markets Latin America Net Total Return Index (Net dividends reinvested) (the "Benchmark Index") denominated in US dollars and representative of large-cap and mid-cap stocks across Latin America emerging markets countries and to minimize the tracking error between the Fund's performance and the performance of the Benchmark Index.

The anticipated level of tracking error in normal market conditions is indicated in the prospectus.

MSCI's website (www.msci.com) contains more detailed information about the MSCI indexes.

The Benchmark Index is a net total return index. A net total return index calculates the performance of the index constituents on the basis that any dividends or distributions are included in the index returns after withholding tax retention.

The Fund seeks to achieve its objective via indirect replication by entering into an over-the-counter swap contract (financial derivative instrument, the FDI"). The Fund may also invest in a diversified portfolio of international equities, whose performance will be exchanged against the performance of the benchmark Index via the FDI.

In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed.

**Intended Retail Investor:** This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

**Redemption and Dealing:** Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the MULTI UNITS LUXEMBOURG prospectus.

As this is a non-distributing share class, investment income is reinvested. the accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

Order Schedule: Orders to buy and/or sell (redeem) shares received and accepted by 06:30 PM on any Luxembourg business day are ordinarily processed on the same day (using the valuation of that day).
