

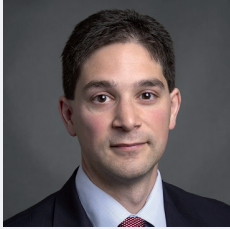

INVESTMENT OBJECTIVE

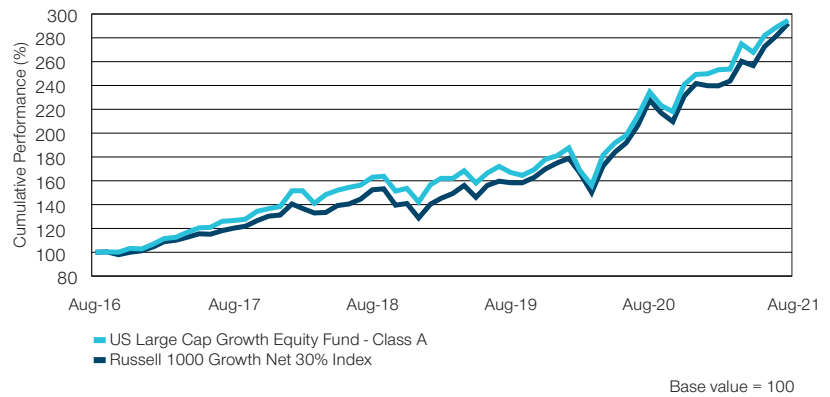
