### Nordea 2 – Global Sustainable Enhanced Equity Fund, BI-NOK Share Class

The management company is Nordea Investment Funds S.A., a company of the Nordea Group.

#### Objectives and investment policy

The fund's objective is to provide shareholders with investment growth in the long term.

In actively managing the fund's diversified portfolio, the management team selects companies with a particular focus on their ability to comply with international standards for environmental, social and corporate governance, and to offer superior growth prospects and investment characteristics. The team targets a return in line with the global equity market, and a low carbon footprint. Furthermore, the fund applies additional negative screening to exclude specific sectors or companies based on environmental, social and corporate governance (ESG) criteria.

The fund mainly invests in equities of companies from anywhere in the world.

Specifically, the fund invests at least 75% of total assets in equities and equity-related securities.

The fund will be exposed (through investments or cash) to other currencies than the base currency.

The fund may use derivatives and other techniques for hedging (reducing risks), efficient portfolio management and to seek investment gains. A derivative is a financial instrument which derives its value from the value of an underlying asset. The use of derivatives is not cost or risk-free.

The fund is promoting environmental and/or social characteristics as per Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR). The fund is subject to Nordea Asset Management's responsible investment policy.

Nordea Asset Management conducts a thorough due diligence on external data vendors to clarify applied methodologies and verify data quality. However, as the regulation and standards of non-financial reporting is rapidly developing, data quality, coverage and accessibility remains challenging - especially for smaller companies and less developed markets.

Any investor may redeem its shares in the fund on demand, on a daily basis.

This fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

While the fund compares its performance against the MSCI ACWI Index (Net Return), it may freely select the securities that it will invest in. Risk characteristics of the fund's portfolio will bear resemblances to those of the reference index.

This share class is not distributing dividends. Income from investments is reinvested.

The fund is denominated in USD. Investments in this share class settle in NOK. USD/NOK fluctuations may lead the performance in NOK of the share class to significantly deviate from the fund performance in USD.

#### Risk and reward profile



The indicator measures the risk of fluctuations of the Net Asset Value of the share class based on the last 5 years volatility and places the fund in category 5. This means that the purchase of units in the fund is connected to **medium risk** of such fluctuations.

Please note that category 1 does not mean a risk free investment.

Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the UCITS, as the category might change in the future.

Following risks are materially relevant to the UCITS but are not adequately captured by the synthetic indicator and may cause additional loss:

- **Depository receipt risk:** Depository receipts (certificates that represent securities held on deposit by financial institutions) carry illiquid securities and counterparty risks.
- **Derivatives risk:** Small movements in the value of an underlying asset can create large changes in the value of a derivative, making derivatives highly volatile in general, and exposing the fund to potential losses significantly greater than the cost of the derivative.
- **Emerging and frontier markets risk:** Emerging and frontier markets are less established, and more volatile, than developed markets. They involve higher risks, particularly market, credit, legal and currency risks, and are more likely to experience risks that, in developed markets, are associated with unusual market conditions, such as liquidity and counterparty risks.
- **Securities handling risk:** Some countries may restrict securities ownership by outsiders or may have less regulated custody practices.
- **Taxation risk:** A country could change its tax laws or treaties in ways that affect the fund or shareholders.


